



## **CONSENT for Personal Data Processing**

I agree to the processing of my personal data, including: name, surname, phone number, email address, place of residence, age, citizenship, education level, profession, gender, proficiency in foreign languages, by the Regional Labour Office in Krakow, located at Plac Na Stawach 1, 30-107 Krakow, for the purpose of providing information regarding recruitment details for the „Live and Work in Malopolska (stage 1)” project, a strategic initiative for Malopolska, co-financed by the European Funds. I provide my personal data voluntarily and I may withdraw it at any time.

I have read the information provided below regarding the processing of my personal data, in accordance with the article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council, dated April 27, 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR).

### **INFORMATION CLAUSE processing of the personal data**

1. The Administrator of personal data is the Regional Labour Office in Krakow, located at Plac Na Stawach 1, 30-107 Krakow. You may contact us by email at kancelaria@wup-krakow.pl, by phone at +48 12 42 87 870, in writing or in person at the provided address.
2. The Administrator has appointed a Data Protection Inspector, whom you may contact by email at ochronadanych@wup-krakow.pl or in writing to the address of the Administrator's registered office.
3. The 6th (1)(a) article of the GDPR is the legal basis of personal data processing.
4. The personal data category: name, surname, phone number, email address.
5. Personal data will be processed in order to provide information on the details of recruitment to the project "Live and work in Małopolska (stage 1)", co-financed by the European Funds of an operation of strategic importance for Małopolska
6. The personal data may be disclosed to other entities authorized under the law and may be entrusted to third-party processors, e.g. in connection with the execution of contracts for IT services.
7. The agreement for the processing of personal data may be withdrawn at any time by sending an email notification to the address integracja@wup-krakow.pl or by sending a written notification to the address of the Administrator's registered office. The withdrawal of the agreement does not affect the lawfulness of processing carried out on the basis of consent before its withdrawal.
8. Personal data will be retained until the consent is revoked or the purpose stated in the consent is fulfilled, and thereafter - in cases where required by the provisions of the Act of 14 July 1983 on the national archival resource and archives (Journal of Laws 2018, item 217 as amended) – for the period specified in those provisions.
9. Regarding the above, you are entitled to:
  - 1) the right to access your personal data,
  - 2) the right to correct your personal data,
  - 3) the right to erase your personal data,
  - 4) the right to restrict the processing of your personal data,
  - 5) the right to withdraw your consent at any time, which does not affect the lawfulness of processing based on consent prior to its withdrawal,
  - 6) the right to lodge a complaint with the President of the Personal Data Protection Office at the following address: Stawki 2, 00-193 Warsaw.
10. Providing your personal data is voluntary, but necessary to achieve the goal specified in point 5.
11. Your personal data will not be processed in an automated or profiling manner.
